**When you document the "Problem,"** use a clear and complete notation or description regarding the client's current complaint(s), condition(s), assessment of client and/or reason(s)

### **Behavioral Health Medical Records**

Electronic health records (EHRs) require similar methods, but the unique nature of EHRs requires extra precautions  
 1 Make sure auto-fill and keyword features are turned off  
 Watch for "cloned" notes—notes that appear identical for different visits; these may not reflect the uniqueness of the encounter or the patient's description
